Kolhapur (Maharashtra, India) and Tukaram Krishnaji Kolekar Arts and Commerce College, Nesari ,Kolhapur , Maharashtra, the two institutions (organizations) agree to the following statement of intent on educational, and skill development cooperation.

Cooperation and development of activities may extend to any fields and subjects in which the two institutions (organizations) may identify shared interests. The initial area of cooperation is academic and educational collaborations.

1. Invitations to skilled personnel to inform about welfare schemes for teaching and non-teaching staff
2. Organization of Bank Training camps for students
3. Organizations of expert lectures on Banking and Finance Management

Both parties agree that all necessary arrangements to implement this general agreement must be negotiated according to the regulations of each institution. Both parties recognize that this General Agreement establishes a foundation of mutual understanding and interest and does not in itself entail any financial obligations to either organization.

This agreement for partnership, cooperation and any helpful exchange shall remain in effect for a period of five (5) years from the date of the last signature, with the understanding that it may be terminated by either party given three months written notice to the partner organization.

This agreement may be amended with the consent of both organizations through a written addendum executed by authorized individuals from both organizations.
